This year we've added an additional day so the Powwow will begin on Thursday. In recognition of our 30-years we are providing a special anniversary gift to all our Ponca elders in attendance. Elders can pick up their gift at the Breakfast and Bingo event Saturday morning or at the Tribal Council booth at the Powwow grounds. There will be even more activities being held in conjunction with the Powwow as well including a first ever Ponca member "Meet & Greet" being held on Thursday. More details of all the different activities are included in this Newsletter as well as on all our social media pages.

We are very excited for everyone to see and

experience the new Powwow arena. Due to repeated storms hitting the area, Tribal Council and staff recognized the need to redo the arena along with some much needed additions to the entire area as well. Thanks to the Poncaowned business Lacreme Construction this dream became a reality over the summer. A huge shout out to Curtis Boschult and his crew for working tirelessly to get everything done on time for Powwow. We are now proud owners of one of the largest arenas in the Midwest, a much larger MC (Crow's Nest) booth, and stateof-the-art kitchen. This June we also planted our own Ponca corn on the arounds, be sure to check it out located behind the Earth Lodge.

The Tribal Council recently approved an Agricultural Resource Management Plan (ARMP) that will help guide us as we continue to look at ways to improve and develop some of our land. As a part of this we were

excited to announce that we are the recipient of a \$4.8 million grant to help us build a corral system and processing plant for herd management. Once complete this will allow us to provide even more buffalo meat to members nationwide and will create new job opportunities for tribal members. We will keep you updated as we progress in these activities.

PONCA ORTHOGRAPHY

ACCENT MARKS:

The **acute [á]** accent indicates primary stress on a syllable, while the **grave [à]** accent indicates secondary stress.

BASIC VOWELS:

A/a /ä/ as in the a in "father"

E/e /ā/ as in the a in "ate"

I/i /ē/ as in the e in "me"

∫ /ʃ/ as in the i in "tip"

O/o /ō/ as in the o in "go"

U/u /ü/ as in the u in "flu"

/ə/ schwa as in the initial and final sounds in "America"

NASALIZED VOWELS:

Nasalized vowels are indicated by the diacritic **ogonek** [,]. The nasalized vowels in Ponca are pronounced in the same way as their counterparts above except that the air passes through both the mouth *and* the nose.

SPECIAL CONSONANT SOUNDS:

Š/š /sh/ as in the sh in "show"

Ž/ž /zh/ as in the s in "leisure"

Č/č /ch/ as in the ch in church

D/đ /th/ as in the th in "them"

X/x /x/ as in the ch of German "Bach"

APOSTROPHES:

The **apostrophe** (') indicates a glottalized release (or "ejective") when it follows the consonants p, t, or k (and sometimes x). **Following all other letters**, the **apostrophe** indicates a glottal stop, which is a brief closure of the vocal cords, as in the English expression uh-oh.

Meet Your Language Instructors: Gwendolyn Santiago-Wright

- Q: Please introduce yourself in Ponca
- A: Đat'ía, ižaže wít'ake Mášàzí Wačígaxè. Níp'úkì P'ák'áíye Wagáze Wáđí bđì ha. Hello, my name is Dancing Yellow Feather, I am the Norfolk Ponca Language Instructor.
- Q: What are you passionate about?
- A: I am very passionate about my family, I'm very passionate about my job, to just learn the language and meet different, many different people, many different Tribes. Just to teach people a language that we couldn't be taught before, that was taken from us, very passionate that we are able to share and teach people our ways.
- Q: What family do you come from, your ancestor, clan, and do you have a traditional given name?
- **A:** I am the daughter of Robin E. Wright and Javier Santiago, and I am also the granddaughter of Loyalee Wright and Thomas McAnally. Otto Birdhead is my great grandfather. Yellow Horse is who I



am the descendant of. I am part of the Buffalo Clan. We are the feeder of the People.

- Q: What do you wish to achieve out of the Language Program?
- **A:** I wish to achieve to teach our younger youth, our Elders, our middle age relatives how to speak Ponca, even if you're not Ponca I want to teach other people about our language. Just to bring back our history and our ways and just to make our Tribe stronger. I wish to take this to when I'm very old. I wish to become a fluent speaker, to have other people become fluent speakers as well.
- Q: Where are you from?
- A: I am from Norfolk, Nebraska, born and raised.



- Q: Do you have any nicknames?
- A: Yeah I have Quincy's my nickname, Squincy.
- Q: What is your favorite movie and/or book?
- **A:** I have a lot of favorite movies, I'd probably say my number one is the Harry Potter series. Books, I don't really have a favorite book.
- Q: What is your favorite childhood memory?
- A: My favorite childhood memory would be when me and my niece would go to my grandmas house and we would go to the Dollar store, and we'd only have to pick, so like at the Dollar store you can pick five things and it'd be five dollars, and we'd only pick things, so we'd always share our things. Then we'd go home and like, play and do all that

- stuff, I think that'd be my favorite, just spending the weekend with my grandma.
- Q: Is there anything else you'd like to add about vourself or the language program?
- **A:** One thing I want to add is this is just a very honorable job and honorable thing that we're learning. And I'm very very passionate about this, so I just want to say thank you for everyone who supports me, and thank you for my teacher, my coworkers, my supervisors, I'm very thankful to have them there by my side to help me walk this path that I'm going down, and just all the positive comment. I also just want to encourage everybody else to learn the language and don't be scared to try something new, like if you have a drive to do something, do it, don't hesitate. And I just want to say thank you.

Community of Neligh returns pipe to the Ponca Tribe

On July 3, the Antelope County Museum and the township of Neligh invited the Ponca people and elders for lunch and the return of a Pipestone Pipe. The pipe was given to the museum as part of a Native American collection many years ago. These pipes are used for tribal ceremonies, and should not be on display in museums. After conversations with the museum's Exeutive Director, Donna Hanson, the museum honored the Tribe's wishes, and returned the pipe to the Tribe. A speech of gratitude and



honor was given by one of the community's eldest residents.

The Ponca people and the town of Neligh have a relationship that goes back to the Ponca's trail of tears in the late 1800s. White Buffalo Girl was a year-and-a-half-old Ponca child who died along the way, and was buried in Neligh. The town promised to continue to look after her grave. "We've

never forgotten the promise that they gave to us to take care of her grave and always respect her in that way. We always try to give back in any way that we can," said Ponca Tribe of Nebraska Culture Director Ricky Wright.

After the presentation, Junior Ponca Princess, Taliah Zephier, USD Junior Princess, Nevaeh Wright, along with some of the Ponca youth group dancers in full regalia, and the Horse Drum Group held an exhibition dance for the town's people.

Culture team receives training on artifact preservation

In mid-June, The Culture and Language team invited conservation experts from The Ford Conservation Center of History Nebraska as consultants to the Community Building in Niobrara.

The specialists offered a two-day hands-on workshop on the process of examining, cleaning, repairing, and identifying damage, along with how safety precautions for using chemicals while cleaning artifacts.

Over the course of the training, Rebecca Cashman, Objects Conserva-



tor, explained the need for safety procedures for artifact cleaning, as historically, arsenic and other chemicals have been used to repel insects. Cashman also demonstrated how to vacuum artifacts without compromising the artifact's integrity. After the demonstration, Teresa Foley, Tribal Historian Preservation Officer and bead enthusiast, practiced stabilizing the beadwork on a sash and pipe bag.

Hilary Lefevere, Paper Conservator, brought her cleaning kit to demonstrate how to clean up and repair important Ponca historical documents, records and photos.

With this training, the Culture and Language team has been able to begin cleaning the items that will go in the Tribes Museum in the Community Building. The Museum will be open 1-6 pm throughout Powwow.

Tips for addressing bullying as school starts

Summer is starting to come to an end, and the school year will soon begin again. I have seen so many children deal with bullying and think to myself, "when this is going to end?" As a parent and advocate against violence, we want the best for our children.

Bullying is aggressive behavior that is intentional and involves an imbalance of power or strength. It is a repeated behavior and can be physical, verbal, or relational. While boys may bully others using more physical means, girls often bully others by social exclusion. Bullying has been a part of schools and workplaces for years. More recently, technology and social media have created a new venue for bullying. Cyberbullying is bullying that happens online and via cell phones. Websites like YouTube, Instagram, and Snapchat allow kids to send hurtful messages to other children 24 hours a day. Some sites, like Instagram, allow for users to create multiple accounts that can't be traced to the original creator and can be used to anonymously bully others.

Preventing and stopping bullying involves a commitment to creating a safe environment where children can thrive, socially and academically, without being afraid. The American Psychology Association (APA) recommends that teachers, parents, and students take the following actions to address bullying.

Teachers and school administrators:

Be knowledgeable and observant.

Teachers and administrators need to be aware that although bullying generally happens in areas such as bathrooms, playgrounds, crowded hallways, and school buses as well as via cell phones and computers (where supervision is limited or absent), and it must be taken seriously. Teachers and administrators should emphasize that telling is not tattling. If a teacher observes bullying in a classroom, he/she needs to immediately intervene to stop it, record the incident, and inform the appropriate school administrators so the incident can be investigated. Having a joint meeting with the bullied student and the student who is bullving is not recommended—it is embarrassing and very intimidating

for the student that is being bullied.

Involve students and parents.

Students and parents need to be a part of the solution and involved in safety teams and antibullying task forces. Students can inform adults about what is really going on and teach adults about new technologies that kids are using to bully. Parents, teachers, and school administrators can help students engage in positive behavior and teach them skills so that they know how to intervene when bullying occurs. Older students can serve as mentors and inform younger students about safe practices on the internet.

Parents:

Parents of kids being bullied.

Observe your child for signs they might be being bullied.

Children may not always be vocal about being bullied. Signs include ripped clothing, hesitation about going to school, decreased appetite, nightmares, crying, or general depression and anxiety. If you discover your child is being bullied, don't tell them to "let it go" or "suck it up." Instead, have open-ended conver-

sations where you can learn what is really going on at school so that you can take the appropriate steps to rectify the situation. Most importantly, let your child know you will help them and that they should try not to fight back.

Teach your child how to handle being bullied.

Until something can be done on an administrative level, work with your child to handle bullying without being crushed or defeated. Practice scenarios at home where your child learns how to ignore a bully and/or develop assertive strategies for coping with bullying. Help your child identify teachers and friends that can help them if they're worried about being bullied.

Set boundaries with technology.

Educate your children and yourself about cyberbullying and teach your children not to respond or forward threatening emails. "Friend" your child on Facebook and other social media platforms and set up proper filters on your child's computer. Make the family computer the only computer for children and have it in a public place in the home where

it is visible and can be monitored. If your child has a cell phone, choose settings that will keep your child safe, like removing an app's access to the cell phone camera or microphone. Let them know you will be monitoring their text messages. As a parent, you can insist that phones are stored in a public area, such as the kitchen, by a certain time at night to eliminate nighttime bullying and inappropriate messaging. Parents should report bullying to the school and follow up with a letter that is copied to the school superintendent if their initial inquiry receives no response.

Parents should report all threatening messages to the police and should document any text messages, emails, or posts on websites.

Parents of kids engaged in bullying:

Stop bullying before it starts.

Educate your children about bullying. It is possible that your child is having trouble reading social signs and does not know what they are doing is hurtful. Remind your child that bullying others can have legal consequences.

Make your home "bully free."

Children learn behavior through their parents. Being exposed to aggressive behavior or an overly strict environment at home makes kids more prone to bully at school. Parents/caregivers should model positive examples for your child in your relationships with other people and with them.

Look for self-esteem issues.

Children with low selfesteem often bully to feel better about themselves. Even children who seem popular and well-liked can have mean tendencies. Mean behavior should be addressed by parents and disciplined.

Students:

Report bullying and cyberbullying.

It is important for students to report any bullying to a parent or an adult they trust. Often kids don't report cyberbullying because they fear their parents will take away their phone or computer. Parents will support their child's reports of bullying and not take away their phones consequently. It is important for kids to remember that bullying is wrong and should be handled by an adult.

Don't bully back. It may be difficult to not bully back, but as the saying goes, two wrongs don't make a right. Try not to show anger or tears. Either calmly tell the bully to stop bullying or simply walk away.

Avoid being alone.

Whenever possible, avoid situations where there are no other students or teachers. Try to go to the bathroom with a friend or eat lunch in a group. When riding the bus, sit near the front. If you know a student who likes to bully others is in an area where you normally walk to lunch or class, try to use alternative hallway

routes.

Remember, report bullying of yourself or other students to your teacher, coach, principal, and/or parent.

Conclusion

Students who experience bullying may feel over-whelmed, depressed, or anxious. If your child or student is having trouble at school or with friends as a result of bullying, a mental health professional, such as a psychologist, can help your child develop resilience and confidence. This will enable your child to be more successful both socially and academically.

The Ponca Tribe of Nebraska uses the Federal government's Child Care and Development Fund to provide assistance to families who need child care due to work, work-related training and/or attending school.

In order to qualify for this benefit program:

- You must be a parent or primary caregiver responsible for children under the age of 13 years of age, or under 19 if incapable of self-care or under court supervision who needs assistance paying for daycare
- The children must be enrolled Ponca Tribe of Nebraska members or have their enrollment pending
- In order to qualify you must be either employed or enrolled in a training or education program
- You must reside in one of the Ponca Tribe of Nebraska's Service Delivery Areas
- Your daycare provider must have their business in one of the tribe's Service Delivery Areas
- Once you have confirmation from the State of Nebraska showing denial for their Child Care Subsidy Program, you are eligible to be considered for our Child Care and Development Fund program.

Building for the Future

Ponca students nationwide are invited to apply by August 15, 2024 for this need-based scholarship focusing on career development.

Selection:

- · All eligible students will be identified.
- On August 15th of the relevant school year, a drawing will be held; and
- The student whose name is drawn will be awarded the scholarship. (One winner per school year.)

Provisions:

- The student must have his/her paperwork complete by the August 15th deadline:
- If awarded, funds will go directly to the school and will be applied to the student's "unmet need."

Eligibility:

- The student must be enrolled in some type of Adult Vocational Training Program or working toward a bachelor's degree.
- The student must provide proof of enrollment in the Ponca Tribe of Nebraska
- The student must provide proof of graduation from high school or completion of their GED.

 The student must complete and submit the following forms: Application, Contract, and Financial Need Form.

Requirements:

- The student must maintain satisfactory academic progress with an accumulative GPA of 2.5 or better for the term funded.
- If the student does not maintain the required 2.5 GPA, they must refund the scholarship.
- The student must also submit an official transcript to the Ponca Tribe of Nebraska Department of Education for the term funded.

Scholarship amount is \$1,000.00 for the 2024-2025 school year.

What ID can I use to vote?

ID must have your name and photo. It can be expired. Acceptable forms of photo IDs include:

- Nebraska driver's license/state ID
- U.S. passport, military ID, tribal ID
- · Hospital, assisted-living facility or nursing home record
- Nebraska political subdivision ID (state, county, city, school, etc.)
- Nebraska college or university ID

What will NOT be accepted?

- · Birth certificate
- Medicare/Medicaid card
- · Out-of-state driver's license
- Out-of-state college ID
- Social Security card
- Store membership card
- Utility bill/bank statement
- · Voter registration acknowledgement card

When does voter **ID take effect?**

The first Nebraska election requiring voter ID will be the statewide primary in 2024:

May 14, 2024

All elections in Nebraska after that will require voter ID.

In 2022, Nebraska voters approved a constitutional amendment requiring voter ID. In June 2023, the governor signed into law LB514, the bill putting voter ID into effect.



What if I forget my ID?

You will fill out a provisional ballot. For your ballot to count, you will need to present an acceptable form of photo ID to your county election office on or before the Tuesday after the election.

How do I vote with voter ID?



IN PERSON

Present an acceptable form of photo ID or vote provisionally.



EARLY IN OFFICE

Present an acceptable form of photo ID or vote provisionally.



EARLY BY MAIL

Write driver's license/state ID number on early voting application or enclose a copy of acceptable form of photo ID or reasonable impediment certification with application.



BY-MAIL PRECINCTS OR BY-MAIL SPECIAL ELECTIONS

Write driver's license/state ID number on ballot return envelope or enclose a copy of acceptable form of photo ID or reasonable impediment certification in ballot return

What if I can't afford an ID?

You can get a free state ID for voting from the DMV. If you were born in Nebraska and need your birth certificate to get a free state ID, you can get a free certified copy of your birth certificate from the Nebraska Department of Health and Human Services. A birth certificate is not an acceptable form of photo ID.

What if I can't get an ID?

If you have a reasonable impediment, you can complete a certification instead of presenting a photo ID. Reasonable impediments are:

- Inability to obtain a valid ID due to:
 - o Disability or illness
 - o Lack of birth certificate or other required documents
- · Religious objection to being photographed

Transformational Training and Workforce Development with industrial robotics

A new industry-certified training program supported by the Heartland Robotics Cluster is upskilling Nebraskans to navigate a future or work that includes collaborative and industrial robotics.

The Heartland Robotics Cluster (HRC) is part of a \$25 million multi-year grant from the U.S. Department of Commerce, **Economic Development** Administration (EDA). NIS is one of eight community partners in the HRC. \$4 million of the grant goes directly towards "transforming NIS into a vibrant hub for anyone building, researching, prototyping, or programming the machines of the future – at any skill level," according to the NIS website.

The program offers core certification training on Universal Robots collaborative robot arms as well as application-specific training, such as robotic welding. Participants gain access to advanced equipment like 3D printers and laser cutters, to further develop skills and expose participants to the latest innovations.

Program Coordinator John Strope said NIS has been operating for

more than a year, and the Universal Robots CORE Training program for the past few months. NIS is now introducing a new pairing to the core program with application training using robotic welding.

Ponca Economic Development Corporation (PEDCO), a tribal non-profit organization responsible for providing economic development activities for the Ponca Tribe of Nebraska, sponsored three individuals to go through the training program July 8-12 at Nebraska Innovation Studio.

Training and getting certified in robotic arm operation increases job satisfaction, Strope said. "These machines do the jobs that people don't want to do, or that are hard on people's bodies, or [the robots] take away the boring elements of someone's work so that they

can focus on the things that actually matter."

The three individuals that went through the CORE training and robotic arm welding sponsored by PEDCO were—Eileen DeCora of Sioux City, Lightning Wakute of Sioux City and Adrian Villalpando of Norfolk. None of them had previous experience in robotics or automation. Wakute is appreciative of the process that the program offered, thinking they would just be learning slides all day. They jumped into using the robotic arms after the initial safety and basic information. Wakute said being a visual learner and having the hands on learning right away was enough for him to start putting the pieces together and start learning.

Wakute said he had been doing hard labor jobs his entire life. Learning and being in this new experience was surprising. He said he didn't think he was going to enjoy it as much as he did. He said he was hesitant to pursue a career he knew nothing about going into it.

"After we got done [the first day] I went home and already started looking at more and more example videos on things I could try to improve on," Wakute said.

For DeCora, she found her motivation to come to the training so that she could show her kids that if she can do it, they can, as well.

"I never thought this was for me...or I'd be able to do this," DeCora said.

Villalpando said he was most excited to learn how to use the arm for welding. After the training he has been inspired to learn how to weld by hand and to use the robotic arm in the future.

"I'm so proud of myself," Decora said.

To get involved, Strope said that NIS training is open to anyone over the age of 18. Regardless of age, background or perceived skill-level. Individual fees range from \$200 to \$1000.


